Weaving I will be held February 5, 8, 9, 12; 12:30-3:30pm. Kathleen requested more helpers are needed to assist new learners. Another rigid heddle class will be held April 22, 23, 25, and 26 from 9-12. Seven new weavers participated in the last class.

Angela reported Weaving III will be held February 6, 8, 13, 15, 20; from 9am-12. She also requested members sign up on a class wanted list for a fall Weaving III.

The sign up procedure was reiterated as members need to sign up on the waiting list and then when an opening is available, the member must pay for the class as they are listed on the class list.

"Be in the Know" will be held on February 23<sup>rd</sup> from 9-11a.m. to demonstrate inkle loom warping and weaving.

**Federation:** Carol Byrne reported on the AZ Fiber Fest to be held in Verde Valley in April. A box containing donated items is in the room and she encouraged members to contribute other items. Items for the goodie bags have been ordered and will be stuffed in February. The Rec Center has donated magnetic

clips to advertise Sun City West. Melanie Drake is in charge of developing a schedule of volunteers to “man” the Guild’s table.

**Library:** Diane Conery showed a notebook “Loom Repair” to be kept in the weaving room for reference on loom repair. A new addition to the library collection is “Weaving with Rags”.

**Looms:** Paula Dean & Karen Vincent will have a further report next month on loom usage and replacements.

**Membership:** Mary Wilder developed a new WWG Membership Information pamphlet and printed some to be given out with New Membership applications along with Bob’s Variety Discount Cards. They are housed in the cash box behind the Monitor’s desk. Mary reported at the end of 2022 there were 127 members. 21 new members enrolled in 2023. 8 new members have enrolled in 2024 for a total membership beginning in January of 2024 of 116 members. She will be individually contacting members who have not renewed.

**Monitors:** Barbara Colvin; The Board approved an 80 years and + exemption for monitoring and informed the membership of the policy which is in line with many other clubs. Members will need to notify the Monitor chairperson of their exemption. Also, there is a medical exemption for monitoring for those members with health issues who wish to continue membership. There was clarification on monitors reporting and waiting for a second person to arrive in the room. Both morning and afternoon monitors should remain either in the courtyard or at the pool office for one hour placing a note on the door letting those arriving know the whereabouts of the scheduled monitor. If no one shows up after one hour, the monitor can leave for the day. A motion was made by Sharon Morken and seconded by Jan Cobb. The membership approved the motion.
